
Session Objectives:

- 8. Attract tourism investors and developers (specific to Crown land) through longer-term tenure

 - Conservation areas with RAC consensus
 - Conservation areas with No RAC consensus
 - Recreation Areas with RAC consensus
 - Private lands conservation
 - Priority wetland conservation and restoration
 - Priority lakes for management
 - Priority recreation management planning areas
 - Priority private land conservation offset pilot areas
- RAC provided feedback and supplemental perspectives to be considered when RAC reviews the full Recommendations Report in the sixth session.

5.9 COMMUNITY LAND-USE PLANNING AND GROWTH

Joannes Wong, MA

- Municipal Affairs presented on <u>Community Growth and Community Land-Use Planning</u> which included an overview of the following:
 - Context underlying the drivers and challenges of land-use decision-making
 - A review of the Municipal Government Act
 - Tools for regional land-use planning, including Efficient Use of Land Principles, Comprehensive Regional Infrastructure Sustainability Plans
 - Roles in community land-use planning, including the province, municipalities, the Capital Region Board, Industries and land owners, aboriginal peoples and other stakeholders
 - Planning, co-operation and integration including a review of the South Saskatchewan Regional Plan

- Enhancing efficient land use in areas where petroleum and petrochemical investments are expected to occur.
- What are the opportunities to strengthen regional infrastructure, community planning, and development in order to support economic expansion and population growth?
- What are the opportunities to enhance the current level of involvement and partnership by and between various groups (e.g., non-profits, private sector, aboriginal and local governments) and the Government of Alberta, in the area of land-use planning?
- RAC reached consensus on the considerations resulting from their deliberations.
